## **Teaching Assistant Preparation in English (TAPE) Program History**

•Many states, including lowa, have rules regarding the oral competency of all instructors, including teaching assistants.

•As can be seen in Iowa Code 262.9 #24-25, there is a Board of Regents mandate regarding the oral competency of instructors and teaching assistants.

•In response to this mandate, there is a university-wide policy overseen by the Office of the Provost referring to the ability of all instructors being able to communicate appropriately in the language of instruction.

•The Office of the Provost's policy regarding the TAs whose first language is not English can be seen in the <u>University's Operations Manual III-13</u>.

## **TAPE Testing**

ESL Programs has been charged with implementing the certification process for students whose first language is not English (as self-reported on their application for admission) who have been offered a teaching assistantship by their department.

## **TAPE Testing Has Two Steps:**

- English Speaking Proficiency Assessment (ESPA)
- 2. English Language Performance Test (ELPT)



#### ESPA

- A test of oral proficiency that elicits language used in tasks commonly found in the classroom.
- The test is approximately 45 minutes and made up of:
  - A 20-minute preparation period
  - A 20-minute recording including summarizing information, defining terms, describing a visual, and making an announcement.
- At least two raters independently and blindly rate each sample.

## **Current Exemptions from ESPA**

•Students with an official valid (within the last two years) iBT Listening score of 25 and an iBT Speaking score of 26

- •Students who obtained degrees at institutions in which the language of instruction was English. This includes:
  - Undergraduate degrees and/or
  - Continuous attendance of English-language schools since the age of 12 (or younger)

•Students who served as teaching assistants at other institutions of higher learning in which the language of instruction is English, provided that they were listed as the instructor of record for a course or led a discussion section in English for at least one year, with a year defined as either two academic semesters or three academic quarters.

•Requests for exceptions regarding the ESPA can be submitted for evaluation to a committee consisting of the Director of ESL Programs, the Associate Dean for Administrative Affairs in the Graduate College, and a representative from University Human Resources.

# IOWA

## ELPT

- The ELPT is the second in the two-test sequence. The test is designed to measure the prospective teaching assistant's ability to communicate in English in a classroom context in their own field of study.
- It consists of a 10-minute presentation on a topic suitable for undergraduates in an introductory-level class in their discipline (or other courses they are expected to teach). During the presentation, the listeners assume the role of undergraduates to ask questions.





## **Other Exemptions**

•Currently, there is **no test score or experience** that qualifies a student for an exemption from the ELPT.

•However, a score of 60 on the ESPA will exempt a student from the ELPT.

### **Certification Levels**

- When the rating is completed, each test taker receives a Certification Level. This and a Feedback Form for the student are uploaded to the TAPE app.
  - A = Take full responsibility for a lecture or discussion class
  - B = Handle a discussion section or supervise a lab section with minimal supervision
  - C = Assist in a lab situation with immediate supervision or teach a foreign language class where the language of instruction is not English
  - **D** = Conduct office hours (one-on-one interaction only)
  - E = Grade papers or handle other duties that do not require

## **Procedures after testing**

- When students pass both tests and receive the certification level required by the department...
- During the semester the students teach their first class, they take TAPE:5330 TAPE Orientation, a support class in which students discuss classroom expectations, student interactions, and cultural differences.
- ESL Programs also does a follow-up observation during that first semester that does not evaluate the teaching assistant, but rather provides support to the teaching assistant.

## **Procedures after testing** (continued)

- If the graduate student passes the ESPA (the first test) but does not achieve the needed certification level on the ELPT, the student enrolls in TAPE: 5300 TAPE Presentations. The student is eligible to retake the ELPT at the end of the semester.
- If the graduate student does not pass the ESPA, the student enrolls in TAPE:5100 TA Preparation: Pronunciation, Fluency Building, and Culture. The student is eligible to retake the ESPA at the end of the semester. If they pass, then they will take the ELPT as well.
- Students who do not achieve their necessary level of certification and who do not enroll in a course will need to wait a year before being retested. (A retest without taking a course can only be done once.)

#### **Re-certification**

 TAs who are certified at level B can be re-certified at an A level if the department requests an observation for re-certification.




## **Guidelines for Departments**
