This course is based on the syllabus for the professional examination “Models for Life Contingencies (MLC)” given by the Society of Actuaries.

The course will review Chapters 1 to 7 and cover Chapters 8 to 13, but excluding Sections 10.7 and 11.5, of the official textbook *AMLCR*.

There will be five (5) exams. The first exam will be given in class on Thursday, August 28. The other four exams are given in the evenings of September 12 (Friday), September 26 (Friday), October 17 (Friday), and October 29 (Wednesday), in 140 SH. **You are to use an official SOA calculator.** Tentatively, the final grade (H.W. 7% + Exams 7% + 20% + 20% + 20% + 26%) will be assigned as follows:
